The Division of Air Resources is hereby submitting amended Air Pollution Control Regulation No. 27, "Control of Nitrogen Oxides Emissions" and the following miscellaneous and alternative Reasonably Available Control Technology (RACT) consent agreements as formal revisions to the Rhode Island State Implementation Plan (SIP); Cranston Print Works, Facile Holdings, Quality Spraying and Stenciling, Guild Music, University of Rhode Island, Algonquin Gas Transmission Company, Bradford Dyeing Association, Hoechst Celanese Corporation, Rhode Island Hospital, Dewal Industries, Victory Finishing Technologies, Inc., Osram Sylvania Inc. and Naval Education and Training Center.

The amended Regulation No. 27 will replace the original Regulation No. 27, which was promulgated on 1 February 1994. The amendments to Regulation No. 27 require monthly rather than daily fuel usage measurements, require facilities to maintain the quarterly fuel usage reports at the facility rather than submitting the reports to the Division and specify alternate scenarios for measuring fuel usage in each piece of combustion equipment.

The RACT consent agreements have been developed as required by Regulation No. 27, Regulation No. 15 "Control of Organic Solvent Emissions," and Regulation No. 19 "Control of Volatile Organic Compounds from Surface Coating Operations."


